IMPLEMENTATION

To implement this MOU, First party and Second party will:

- a) Establish monitoring committees to oversee and implement specific areas of cooperation.
- Hold regular meetings to review progress and identify new areas of cooperation.
- c) Collaborate on grant proposals and funding opportunities to support joint projects and initiatives.

DURATION AND TERMINATION:

This MOU shall be effective for a period of 5 years from the date of signing. Either party may terminate this MOU upon written notice to the other party.

MODIFICATION:
