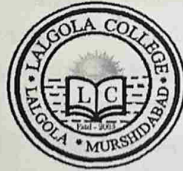

This Memorandum of Understanding (MoU) is made on 5th day of April, 2024 between Jangipur College and Lalgola College for mutual cooperation in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two organisations:

I. Legal Frameworks of Both the Organizations

Jangipur College, established in 1950, is a State Government-aided and affiliated college of the University of Kalyani. The College is included under Section 2(f) & 12(B) of the UGC Act, 1956. The institution has rapidly emerged as one of the most promising educational institutions in Murshidabad, West Bengal. With a strong focus on the dissemination of knowledge, the college offers Undergraduate Courses in Honours and General Courses for the B.A., B.Com.& B.Sc. streams. The institution holds a steadfast commitment to the all-round development of its students, aiming to cultivate their sensibility to beauty, harmony, value systems, culture, social justice, heritage, scientific temper, and the environment. Through this holistic approach, Jangipur College strives to shape self-reliant individuals who actively contribute to their communities. The College, having its campus at Jangipur, Raghunathganj-I, P.O.- Jangipur District - Murshidabad, Pin- 742213, West Bengal, India, is represented by the Principal of the institution, Prof.(Dr.) Prarthita Biswas, hereinafter referred to as the FIRST PARTY (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will hereafter be referred to as Parties.

Lalgola College is situated at a remote and border area of Murshidabad district, West Bengal. Most of the students belong to minority and girl's community. The college is running different UG courses like Arabic, Bengali, Education, English, Geography, History, Political Science, Philosophy, Physical Education and Sanskrit under Kalyani University. II. Purpose of the Agreement

Both the Parties are pleased to enter into an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through the following, but not limited to:

1. Joint teaching and research projects.
2. Collaboration in the areas of academic publications, research activities, field trips, etc.
3. Visits, training, and exchange of faculty, staff, and students.
4. Joint educational/vocational courses.
5. Joint consultancy, scientific publications.
6. Co-hosting and participation in conferences, seminars, symposiums, and workshops.
7. Social and cultural programs.
8. Any other academic activity that is mutually agreed upon and is beneficial to both.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of two years. After these two years, it will be mutually extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination, and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination, or expiration unless otherwise agreed upon between the Parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

V. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent of the other party.
5. There will be no financial involvement by either of the parties.

VII. DISPUTES

If any disputes arise in respect to the MoU, in that case, both organizations will discuss and settle the matter amicably..
